INTRODUCTION

I, Alexei Ramsey, Environmental Investigator with the Texas Commission on Environmental Quality (TCEQ) Austin Regional Office, conducted this investigation concerning a request to place a temporary rock crusher at approximately 0.25 miles Southeast of the intersection of Barr Ln. and Cameron Rd. (Site/Facility), Austin (Travis County), Texas. This request was submitted to the TCEQ Austin Regional Office on October 11, 2019, by Westward

Environmental, INC. (WE), on behalf of the owner and operator, Capital City Crushing, LLC (CCC). The application was received in the Austin Regional Office on October 15, 2019 (See Attachment A). CCC requested a Tier II registration for Portable Crusher #2 (S/N 418092/418095).

As required by Tier II of the Standard Permit for Temporary Rock and Concrete Crushers, the rock crusher will be located no less than 300 feet from the nearest property line, 550 feet from any concrete batch plant or asphalt batch plant and its throughput will not exceed 250 tons per hour (TPH). In addition, the concrete crusher will be operated at least 440 yards from any building which was in use as a single or multi-family residence, school, or place of worship at the time the notification required by section (2) or (3) of the Standard Permit was filed. A map showing the proposed crusher location is included in Attachment A.

Daily Narrative

On October 31, 2019, Mr. Rick Ciampi, Environmental Investigator with the TCEQ Austin Region Office, and I conducted an onsite investigation at the proposed location for the Portable Crusher. During the course of the investigation, it was verified that the minimum distance requirements needed for the authorization of the Tier II rock crusher could be met. All the distances appeared to be in compliance with the requirements listed in TCEQ's Air Quality Standard Permit for Temporary Rock and Concrete Crushers. Specifically, all facilities and associated sources are at least 300 feet from any property line and 440 yards from the nearest off-property receptor.

GENERAL FACILITY AND PROCESS INFORMATION

Process Description

CCC proposes to authorize a temporary concrete crushing facility via the Air Quality Standard Permit for Temporary Rock and Concrete Crushers. The temporary crushing facility will be located in Austin (Travis County), Texas. The subject facility will be located on site temporarily (<180 days/ 1080 hours) and will have a maximum production rate of 250 tons per hour and 270,000 tons per year at a maximum operating schedule of 24 hours per day, 7 days per week. The subject facility will be located at least 300 feet from the nearest property line and will comply with all property line visible emission requirements and opacity limits listed in the Air Quality Standard Permit for Temporary Rock and Concrete Crushers. The facility will have no more than one primary crusher, one secondary crusher, two screens, and any associated conveyors.

BACKGROUND

Current Enforcement Actions

No violations were documented during the course of this investigation.

Agreed Orders, Court Orders, and Other Compliance Agreements

After reviewing the Consolidated Compliance Enforcement Database System (CCEDS) and the Commissioners' Integrated Database (CID), it was determined that the facility has not been subject to agreed orders, court orders, or other compliance agreements within the past five years.

Prior Enforcement Issues

After reviewing the CCEDS database, it was determined that this facility has not received Notices of Violation (NOVs) or Notices of Enforcement (NOEs) within the past five years.

Complaints

After reviewing the CCEDS database, it was determined that this site has not been the subject of a complaint within the last five years.

ADDITIONAL INFORMATION

Conclusions and Recommendations

On October 31, 2019, an investigation concerning the placement of a temporary rock crusher was conducted. The proper information was submitted to the agency, including all the information required in Section 1 and 3 of the Standard Permit for Temporary Rock Crushers. All distance limitations specified in Section 3 were met. It is recommended that CCC should receive a letter authorizing the location of the rock crusher.

Capital City Crushing, LLC will satisfy the conditions of the Air Quality Standard Permit for Temporary Rock/Concrete Crushers. The following is a checklist to demonstrate compliance with the General Requirements and Tier II Requirements. However, this is not an exhaustive list. The complete list of conditions is attached at the end of this application. An area map, plot plan, and project description are also attached with this application to demonstrate compliance. The facility will have a maximum production rate of 250 TPH and may move around on-site but will remain at least 300 feet from the nearest property line and at least 440 yards from any building in use as a residence, school, or church at the time this application was filed.

General Requirements:

- 1 A. This location will comply with this definition of a site.
- 1 B. If crushing concrete, this operation will be located at least ¼ of a mile from a residence, school, or place of worship.
- 1 E. All screen sides will be enclosed and all conveyors greater than 300 feet long shall be covered with a half-moon or equivalent enclosure that covers the top of the conveyor to minimize emissions.
- 1 F. This facility will comply with the property line visible emission requirements.
- 1 G. This facility will comply with the opacity limits listed in the standard permit.
- 1 H. Permanently mounted spray bars will be installed at the inlet and outlet of all crushers, at all shaker screens, and at all material transfer points and used as necessary to maintain compliance with all commission regulations.
- 1 I. Dust emissions from all in-plant roads and active work areas that are associated with the operation of the crusher will be minimized at all times by: treated with dust suppressant chemicals, watered, or paved and cleaned.
- 1 J. All stockpiles will be sprinkled with water, dust suppressant chemicals, or covered, as necessary, to minimize dust emissions.
- 1 K. Raw material and stockpile heights shall not exceed 45 feet.
- 1 L. The crusher will be equipped with a runtime meter.
- 1 M. Written records will be kept for a rolling 24 month period, will accompany the crusher to any site at which it operates, and will include hours of operation including daily start and stop time, throughput per hour at the feed hopper, date the crusher was placed on site, and date the crusher was removed from the plant site.
- 1 N. The subject facility meets the requirements of the standard permit and is therefore exempt from 30 TAC §116.610(a)(1).
- 1 O. This facility will comply with all applicable 40 CFR Part 60, Subpart OOO requirements.
- 1 P. This facility will only crush non-metallic minerals as listed in 40 CFR Part 60, Subpart OOO.
- 1 Q. The crusher and all associated facilities operating under this standard permit shall neither locate (except for crushers in nonoperational storage that have not commenced construction) nor operate on the same site as any other crusher.
- 1 R. There is no fee required for this standard permit.
- 1 S. There is no registration required as described in 30 TAC §116.611.
- 1 T. Crushing operations and related activities shall comply with applicable requirements of 30 TAC §101, Subchapter F.
- 1 U. For any owner or operator with a facility authorized by this standard permit, the TCEQ will not accept an application for authorization of a crushing facility under Texas Health and Safety Code (THSC) §382.0518, Preconstruction Permit, located at the same site for a period of 12 months from the date of notification.
- 1 V. An applicant for authorization of a rock crusher under THSC §382.0518 is not eligible for this standard permit at the same site until 12 months after the application for authorization under §382.0518 is withdrawn.
- 1 W. Maintenance emissions are not included in this permit and must be approved under separate authorization. Startup and shutdown emissions that exceed those expected during production operations must be approved under separate authorization.

Tier II Requirements:

- 3 A. The crusher's feed hopper throughput shall not exceed 250 tons per hour.
- 3 B. The crushers and associated sources will be located no less than 300 feet from the nearest property line.
- 3 C. The crushers and associated sources operating under this standard permit will be located at least 550 feet from any concrete batch plant or asphalt plant, or will not operate simultaneously if located within 550 feet.
- 3 D. The equipment authorized under this section will fall under the equipment requirements and will have no more than one primary crusher, one secondary crusher, two screens, and any associated conveyors.
- 3 E. Except for those facilities that comply with subsection (3)(H) of this standard permit, crushers and associated sources (excluding stockpiles) will not operate for more than 1,080 hours or be located for more than 180 non-consecutive calendar days on site, whichever occurs first.
- 3 G. The crusher will not be located on site without first obtaining written authorization (unless in non-operational storage).
- 3 H. A crusher that provides crushed material exclusively to a single public works project (single contract or same contractor for related project segments), and not to other unrelated projects, and is located in or contiguous to the right-of-way may remain on site and operate for the length of the current project or related segments.
