We are still working on our first response to comments for the Barr Lane tract (Permit #20-28538) and should be uploading it by the end of week next week. In addition to the question in the previous email below, we are wondering if its possible to add an additional office building to our site plans since we are still relatively early into the review process? The building and associated parking would be west of the proposed Arterial A ROW, but still outside of the waterway setback and floodplain.
