ERM2: Applicant: This project requires either an ERI, or an approved waiver to be considered a complete application. An application for waiver (submitted) does not meet the requirements as complete. Please send the request for waiver to John.Clement@austintexas.gov for review. A site visit and/or additional information may be required to complete assessment. If the waiver is approved, then the signed/approved waiver should be included in the application packet and resubmitted for completeness, however if the waiver is not approved, then submit with an ERI.

TR1. Please include the subdivision plat or legal lot letter with the plans.Response: Legal lot status has been confirmed and the letter included in the resubmittal.

DE1: Please provide outlet structure details for the detention ponds.

DE2: Please provide a drainage area map for the entire project site. Provide common points of analysis in both drainage area maps in order to verify DCM 1.2.2.D.
 Response: Please see an updated drainage areas that shows the portions of the property that are not being affected by any proposed construction.

DE/FYI: The Drainage Criteria Manual has been updated to reflect the Atlas 14 changes which affects drainage calculations including pond design, storm sewer design, floodplains, etc. These changes went into effect on January 13, 2020. WQ1: Per ECM 1.9.2.C, "projects in watersheds other than the Barton Springs Zone and the Urban watersheds, must provide water quality controls when impervious cover results in a cumulative total of more than 8,000 square feet of both new and redeveloped impervious cover." Please show compliance.

Response: My apologies for my old code understanding. Not a problem, we have included water quality within this resubmittal for all of the proposed improvements
